DRAFT Zion Lutheran Church – Voter's Assembly Minutes DRAFT January 16, 2022

Gary Klekamp called the meeting to order at 11:20 am. Pastor opened the meeting with the Opening Prayer for a Congregational Meeting.

Attendance: 16 members present with 2 new people requesting membership - Rich and Teresa Albsmeyer, who will be voting members at the next voters meeting in April. Quorum was established.

Minutes: Minutes from the October 28, 2021 meeting submitted by Stacy Stremsterfer were reviewed. Motion by Sue Matzat and seconded by Frank Wallace to approve minutes as printed, MCVV.

Treasurer's Report: Stacy Stremsterfer presented the 2021 budget report showing where we ended the year. She noted some line items were higher in earlier reports given out at meetings due to grant money being used, however those expenses are now grouped into line item named "Reimbursed from Memorial Fund". This makes the budget look more inline instead of extremely high over budget line items. Bank balances as of 12/31/21 were also submitted. Motion to approve Treasurer's report by Brad Mahler and second by Dennis Boesdorfer, MCVV.

Financial Secretary Report: Eric Oschwald presented his year-over-year financial report for October, November and December. Annual giving reports will be in mailboxes soon. No objections to accepting the report by unanimous consent.

Elder's Report: Dennis Boesdorfer reported the Elders had a meeting yesterday with the new Elder, Nathan Van Zelle. They are still assisting Pastor with services and making calls to reach out to members. No objections to accepting the report by unanimous consent.

Trustee's Report: Dale Dobbe reported the fire alarm system had its yearly inspection and thanked those who helped put up and take down the Christmas decorations for the church. Still have not received spotlights for the sanctuary from Ryan Electric due to supply issues. Glisson Heating & Air came to look at the furnace. The drain hole for one of the furnaces was clogged with rust and also inspected the other older units. Discussion was held about replacing more than one of the units. Last year at the January Voter's Meeting it was discussed about purchasing one a year, but no motions were made to set any precedents. Motion by Brad Mahler and seconded by Bob TeRonde to spend up to \$10,000 to replace two furnaces. Discussion was held, MCVV. No objections to accepting the report by unanimous consent.

Education/Stewardship Report: Lindsey Van Zelle reported the Christmas Program went well with 11 kids participating. Next Sunday they will start Sunday School with new Material. Looking into starting at Kids Chime group again since they were used in the Christmas Program and they loved it. No objections to accepting the report by unanimous consent.

Church Council Report: Gary Klekamp reported Eric Oschwald is working on investment policy guidelines for the Glenn Oschwald Parochial Education Fund. With the new Memorial Policy in effect, a letter has been sent to those families with memorial money in accounts that need a decision on how to spend the money since it has been over a year. They have six months to make their decision. Council will be discussing at their upcoming meetings at a possible new partnership with Alliance Defending Freedom, the world's largest Religious Liberty Law firm. Lindsey Van Zelle has started the Mandated Reporter training process with the State of Illinois. Church council approved an end of year bonus for Sue Matzat for \$500. No objections to accepting the report by unanimous consent.

Pastor's Report: Pastor Pritchard reported:

197 baptized members

163 communicant members

Attendance: YTD 48

Communion 42

Completed normal pastoral activities with preparation for Services, Bible Study & Confirmation. Calls are mostly suspended due to COVID surge. Will be spending 10 days in Florida from January 19 thru February 2. ISP Chaplain, counseling, contacts as usual.

Unfinished Business:

Gary Klekamp reported he received a response back from Jeanette Ealey on her mother's memorial funds. She would like to have them transferred to the Building Account. Motion by Dennis Boesdorfer and seconded by Bob TeRhonde to accept Jeanette Ealey mother's memorial money of \$3,229.36 to be transferred to the Building account from Memorial, MCVV. Gary also reported he has been working diligently over the past year trying to get answers on how to correctly reimburse Pastor Pritchard for this health care since he went onto Medicare which was a savings for the Church. Asked voters if he could get their permission to give Church Council to proceed and move forward with the decision on getting Pastor reimbursed. Motion by Bob TeRonde and seconded by Sue Matzat to allow Church Council to make decision on Pastor Pritchard's health reimbursement arrangement, MCVV.

New Business:

Motion by Brad Mahler and seconded by Bob TeRonde to allow \$8,000 for parsonage and \$6,500 for professional expenses for Pastor Pritchard's 2022 income taxes to be retroactive back to January, MCVV.

Motion by Dennis Boesdorfer and seconded by Frank Wallace to adjourn the meeting. Meeting adjourned with the singing of the doxology.
